

# **Exhibitor information**

Remember space is limited, tables are sold as first come first served. The longer you have been an exhibitor with CalComicCon the more likely you will get the same spot.

If you attended the last show, you may have the option of the same location but only if you pay by the deadline and the space hasn't already been assigned.

#### Location:

The 2024 California Comic Convention will be located at the **Hotel FERA**, a **DoubleTree by Hilton**, 100 The City Dr N, Orange, CA 92868 on February 3<sup>rd</sup>-4<sup>th</sup>, 2024.

You may sign up for Exhibitor Tables by returning a signed contract and payment in full. We regret that we are unable to accept partial payments or deposits.

## **Hotels:**

Lodging is available at **Hotel FERA**, a **DoubleTree by Hilton** with a special convention rate of \$153 per night. Please book using the official link to ensure CalComicCon gets room rental credit, and you get table discount. See web site <a href="https://www.CalComicCon.com">www.CalComicCon.com</a> for more information.

#### Fees:

Exhibit tables are 8' with approx. ~6' back space and two chairs. The tables are \$350 each. (6' tables \$290) You are required to collect sales tax for the State of California and therefore need a valid CA resale Number. You cannot turn your table into a booth unless first approved by the show promoter. Tables will not be held past 30th October 2023 unless paid in full.

#### Sales Tax:

The State of California requires that all vendors selling merchandise at CalComicCon to obtain a valid California resale License. Licenses can be obtained for free at <a href="https://onlineservices.cdtfa.ca.gov//#1">https://onlineservices.cdtfa.ca.gov//#1</a>. This link has been posted on the website for your convenience. It is the responsibility of the exhibitor to obtain this Certificate. Failure to do so may result in the State Board of Equalization levying a fine on the exhibitor selling at this event. The California Comic Convention will not be held responsible for an exhibitor's failure to obtain this certificate and will not issue any refund to any exhibitor who is unable to exhibit per the State of California.

#### Memberships:

Two (2) Exhibitor Memberships will be provided with each table. Additional Exhibitor VIP Memberships are available for \$50 each (two additional maximum/table). \*

#### **Hours:**

The set up and takedown time is listed below.

All exhibitors must be checked in with the Exhibitor Liaison and set-up by 9:30 am on Sunday. If the exhibit area is not claimed by 9:30 am, the exhibit space will be considered abandoned and will be available for purchase and setup by another exhibitor.

- \*Everyone must be out of the Exhibit Hall 60 minutes following closing.
- † Load out begins at 5:00 PM.

# **Electricity:**

We will be allowed to plug into wall outlets free of charge.

## **Refunds:**

Cancellations must be submitted in writing; Refunds will be issued according to the following schedule.

Cancel by October 31<sup>st</sup>, 2023 and receive 100% refund. Cancel by January 1<sup>st</sup>, 2024 and receive a 40% refund. No refund will be allowed after January 1st, 2024.

# **Liability Policy:**

The exhibitor is fully responsible for all damage to property owned by the Hotel FERA, a DoubleTree by Hilton or the California Comic Convention, its owners or managers that may result from any act or omission of exhibitor. Exhibitor agrees to defend, compensate, and hold harmless the Hotel FERA, a DoubleTree by Hilton, City of Anaheim, and the California Comic Convention, its owners, managers, officers or directors, agents, employees, subsidiaries, and aliases, from any damages, losses, costs, or expenses arising from or out of or by reasons of any accident or bodily injury to employees and exhibitor invitees which arises from or out of the exhibitor's occupancy and use of the Exhibitor Room premises, the venue or any part thereof. The exhibitor invitee is anyone who enters the exhibition space of sale or show within the Exhibitor Room.

## **Security and provisions:**

The California Comic Convention will provide security which is limited to show staff and professionals inside the Exhibitors Room. Although there will be security, any cash or valuables are requested to be watched by the exhibitor and their staff during the day. As an extra precaution against theft, we ask that exhibitors take extra care in placement of merchandise and cash boxes. Exhibitors are responsible for their own property, and under no circumstances will the California Comic Convention or its personnel be held liable for any loss or damage including but not limited to merchandise, equipment, and/or revenue.
